Ragging is an act, which is likely to cause insult and annoyance of fear or apprehension or threat of intimation outrage of modesty of injury students. This is heinous crime, which is Dominic. There are instances when some psychologically week students have committed suicides in colleges because of ragging Hence ragging is prohibited within or outside the educational institutions.

The salient features of legislation and punishment for indulging in ragging are as follows.

SL. NO	EXTENT OFFENCE	PENALITY
1.	Teasing or embarrassing of humiliating a student.	Imprisonment up to 6 months or fine up to Rs. 1,000/- or both
2.	Assault or use of criminal force or criminal intimidation	Imprisonment up to 1 year or fine up to Rs. 2,000/- or both
3.	Wrongful restraint or wrongful confinement or causing hurt	Imprisonment up to 2 years with a fine up to Rs. 10,000/-
4.	Causing grievous hurt or kidnapping or abducting or committing rape or committing unnatural offence	Imprisonment up to 5 years with a fine up to Rs. 10,000/-
5.	Causing death or abetting suicide	Imprisonment for like or for a term up to 10 years with fine up to Rs. 50,000/-

#### SUSTENTION OR DISMISSAL OF STUDENT FROM THE COLLEGE

- 1. The act provide for suspension of students from the college, if the complaint by the sufferer is found to be prima facie true. The period of suspension depends on the decision of the college which shall be final.
- 2. A student shall be dismissed from the college, if he/she is convicted for an offence mentioned above the undergone imprisonment for a term up to 6 months.
- 3. The ragging will observe in mufti (in plain clothes), in the buses, bus and campus of Educational institutions.
